Please note that the Annual Registration Renewal Fee Report (Form RRF-1) must be filed annually four months and 15 days after the end of the organization's accounting period. The Registry will honor all IRS extensions for annual renewal filing deadlines, including the filing of the Forms RRF-1, CT-TR-1, and IRS Forms 990, 990-PF and 990-EZ. After filing with the IRS, please file Form RRF-1 with the completed IRS informational return together with a copy of all extension requests.

NOTE: *The **Form RRF-1** (with applicable fee) and the **IRS Form 990, 990-EZ, or 990-PF** (required for revenue \$50,000 or above) for the fiscal year ending 12/31/2021 were due on 05/15/2022, unless the entity has received an IRS extension. If you have received an IRS extension, the new filing due date with the IRS becomes the due date to file with the Registry of Charitable Trusts. If you only file IRS Form 990-N, or if your organization is not required to file and does not file IRS Form 990 or 990-EZ because it does not meet the revenue requirements, your organization will be required to file **Form CT-TR-1** with the Registry. Failure to submit the annual reports can cause the organization to be Delinquent with our office.*

Online filing for organizations current in their annual reporting is available. Your **Registration Code** (24923149) is needed along with your **State Charity Registration Number** (CT0279274) to establish and update login credentials (User ID and Password). The link to the Online Renewal System may be found on oag.ca.gov/charities/renewals.

Your organization is responsible for notifying the Registry in writing of any change of address. Changes of address may also be submitted through the Online Renewal System as part of annual reporting or separately.

If your organization contracts with a commercial fundraiser for charitable purposes or fundraising counsel, those entities must also register and file annual reports with the Registry.

Directors of nonprofit corporations are required to adhere to the provisions of the California Nonprofit Corporation Law (Corporations Code section 5000, et seq.).

Trustees for charitable purposes are required to adhere to the provisions of California Probate Code (commencing with section 15000).
